#### **Treatment of Slaves:**

The Prophet Muhammad (صلى الله عليه وسلم) encouraged the equitable treatment of slaves and encouraged their emancipation. While actively taking part in the manumission of slaves, he emphasised the significance of releasing slaves. Imam Bukhari narrated:

Allah's Messenger (صلى الله عليه وسلم) said, "He who has a slave girl and educates and treats her nicely and then manumits and marries her, will get a double reward."8

The concept of mercy embraces all facets of human connection, such as friendly encounters and deeds. It promotes empathy and a kind and helpful society. These صلى الله عليه ) principles, which are founded on the teachings of the Prophet Muhammad وسلم), still serve as the moral compass for Muslims today.
